## Marking Scheme:

1. The marking scheme of examination would be as same as regular practical examination and as below.

- a. **MPT Part-II Examination Scheme ( Second Year MPT)**

(Major Case from Elective subject= 80 marks) + (Minor Case from Elective subject(40) + Minor Case from Non-Elective subject(40) = 80 marks )+ (Spot examination(40) + Viva voce(40) = 80 marks) + (Dissertation =80 marks ) = 320 marks

- A. Students would be given conditions of patient with description and they will have to write assessment by mimicking the actual signs & symptoms of the disease (offline mode).
- B. After completion of the assessment, the candidates will have to scan their document and send it to the chairperson of the examination in PDF format only (Internal Examiner).
- C. The written assessment should be legible and scanned properly using appropriate software. The candidate should ensure that it is readable without any difficulties, before sending it to the examiner.
- D. During case presentation, the same assessment will be shown to the co-examiners.
- E. Case presentation (online mode), Micro Teaching (online mode), Spot examination (offline mode) + Viva voce (online mode) , Dissertation presentation (Online Mode)

## Requirements :

1. The students should have sufficient data, bandwidth (Internet) and hardware setups to fulfill the requirement of the examination.
2. The students should contact the Principal of the institution to know the software (Web meeting tools) and hardware requirements.
3. The students are informed to learn the software interfaces and its function (to be used in exams), well in advance to avoid difficulties.

## Others:

4. There are circumstances, if the candidate faces any unforeseen challenges, are informed to contact their respective college principal, for the resolution.
